OTHERS COME FROM FAMILIES IN CRISIS SUCH AS THE SERIOUS ILLNESS OR DEATH OF A PARENT OR GRANDPARENT, PARENTAL DRUG OR ALCOHOL ADDICTION, FAMILY HOMELESSNESS - ANY SITUATION THAT THREATENS THE CHILD'S SAFETY AND/OR FAMILY STABILITY. THORNWELL'S FOSTER CARE PROGRAM IS DESIGNED TO EQUIP, TRAIN, SUPPORT AND RETAIN WELL-TRAINED FOSTER PARENTS TO ENSURE STABLE FOSTER PLACEMENTS FOR CHILDREN IN SOUTH CAROLINA. THORNWELL FOSTER CARE HAS EXPANDED IN 2020 TO THE MIDLANDS AREA. THERE ARE NOW A TOTAL OF 7 STAFF MEMBERS INCLUDING A DIRECTOR, RECRUITER, PROGRAM COORDINATOR AND 4 FAMILY SPECIALISTS. THE FOSTER CARE PROGRAM HAS ADOPTED TRUST-BASED RELATIONAL INTERVENTION (TBRI), AN EVIDENCE-BASED THERAPEUTIC APPROACH, TO TRAIN FOSTER CARE STAFF TO WORK WITH FOSTER PARENTS TO MEET THE NEEDS OF CHILDREN FROM HARD PLACES. STRENGTHENING FAMILIES IS AN EVIDENCE-BASED FAMILY SKILLS TRAINING PROGRAM THAT WORKS WITH PARENTS/CAREGIVERS AND THEIR CHILDREN FOR 14 WEEKS. STRENGTHENING FAMILIES IS CONSIDERED AN EARLY INTERVENTION AND PREVENTION MODEL. THE PARENTS/CAREGIVERS MUST HAVE A CHILD BETWEEN THE AGES OF 6-11 TO PARTICIPATE, PER GRANT REQUIREMENTS.
